It is your duty to determine, from the greater weight of the evidence, the amount of money damages to be paid the [owner] [tenant] as just compensation for the taking. **USE NOTE** In completing the blanks in this instruction it is not necessary to use the full legal name of condemning authority or legal description of the property involved. All that is necessary is reasonable identification. This instruction is the "statement of issues" to be used in eminent domain proceedings in lieu of UJI 13-302 NMRA. The issues to be decided by the jury in each case should be delineated in simple, concise, understandable terms. When a leasehold estate is involved, in lieu of the word "owner" use the word

"tenant".
