Sections 59-16-44 to 59-16-46 and 59-18-24 NMSA 1978 were recompiled by Laws 1987, ch. 259, § 32, effective June 19, 1987. Laws 1984, ch. 127, §§ 1 to 988, enacts the new Insurance Code codified as Chapter 59A NMSA 1978, effective January 1, 1985. For present provisions in Chapter 59A NMSA 1978, comparable to those in the repealed and recompiled sections of Chapter 59 NMSA 1978, see the Table of Corresponding Sections in Appendix A following this chapter.
