# Laws of 2021 (2nd S.S.), Chapter 1

House Bill 1, aa, w/ec Approved December 9, 2021

#### AN ACT

RELATING TO GENERAL APPROPRIATIONS; MAKING APPROPRIATIONS FROM LEGISLATIVE CASH BALANCES FOR NECESSARY EXPENSES OF THE SECOND SPECIAL SESSION OF THE FIFTY-FIFTH LEGISLATURE; MAKING APPROPRIATIONS FROM THE GENERAL FUND TO THE HOUSE AND SENATE CHIEF CLERKS' OFFICES FOR LEADERSHIP STAFF AND ONGOING OPERATIONAL EXPENSES; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

## Chapter 1 Section 1 Laws 2021 (2nd S.S.)

SECTION 1. SPECIAL SESSION--APPROPRIATION.--

- A. The following amounts are appropriated from legislative cash balances for expenditure in fiscal year 2022 for the following expenses of the second special session of the fifty-fifth legislature:
- (1) for the expense of the house of representatives, three hundred twenty-two thousand three hundred dollars (\$322,300) to be disbursed on vouchers signed by the speaker and the chief clerk of the house of representatives or the chief clerk's designee;
- (2) for the expense of the senate, three hundred five thousand four hundred dollars (\$305,400) to be disbursed on vouchers signed by the chair of the committees' committee and the chief clerk of the senate or the chief clerk's designee; and
- (3) for the expense of the legislative council service, two hundred eighty-six thousand four hundred dollars (\$286,400) to be disbursed on vouchers signed by the director of the legislative council service or the director's designee.
- B. Following adjournment of the second special session of the fifty-fifth legislature, expenditures authorized in this section shall be disbursed on vouchers signed by the director of the legislative council service or the director's designee.

#### Chapter 1 Section 2 Laws 2021 (2nd S.S.)

SECTION 2. APPROPRIATIONS--GENERAL FUND--HOUSE AND SENATE LEADERSHIP STAFF AND ONGOING OPERATIONAL EXPENSES.--

- A. There is appropriated from the general fund to the legislative council service for expenditure in fiscal years 2022 and 2023:
- (1) three hundred fifty thousand dollars (\$350,000) to the house chief clerk's office for leadership staff and ongoing operational expenses as determined by house leadership, to be disbursed on vouchers signed by the director of the legislative council service; and
- (2) three hundred fifty thousand dollars (\$350,000) to the senate chief clerk's office for leadership staff and ongoing operational expenses as determined by senate leadership, to be disbursed on vouchers signed by the director of the legislative council service.
- B. Any unexpended or unencumbered balance remaining at the end of fiscal year 2023 shall revert to the general fund.

#### Chapter 1 Section 3 Laws 2021 (2nd S.S.)

SECTION 3. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.

SECTION 1. Section 1-15-15 NMSA 1978 (being Laws 1969, Chapter 240, Section 365, as amended) is repealed and a new Section 1-15-15 NMSA 1978 is enacted to read:

"1-15-15. UNITED STATES REPRESENTATIVE--CONGRESSIONAL DISTRICTS ESTABLISHED.--New Mexico is divided into three congressional districts to be known and designated as congressional district one, congressional district two and congressional district three."

#### "1-15-16.1. PRECINCTS.--

- A. Precinct designations and boundaries used in the 2021 congressional redistricting are those precinct designations and boundaries established pursuant to the Precinct Boundary Adjustment Act and revised and approved pursuant to that act by the secretary of state as of November 30, 2021.
- B. A board of county commissioners shall not create any precinct, combine precincts or adjust the boundaries of any precinct in such manner that a precinct lies in more than one congressional district. A county precinct map determined not to be in compliance with this subsection shall be rejected by the secretary of state and returned to the appropriate county clerk with a written statement setting forth those instances in which the county precinct boundaries do not comply."

#### Chapter 2 Section 4 Laws 2021 (2nd S.S.)

SECTION 4. Section 1-15-17 NMSA 1978 (being Laws 1969, Chapter 240, Section 367, as amended) is amended to read:

"1-15-17. UNITED STATES REPRESENTATIVE--NOMINATION AND ELECTION.--One representative in congress shall be nominated and elected from each congressional district for voting purposes. Ballots for representatives in congress shall designate the office as congressional district one, congressional district two and congressional district three. Only voters of each district shall be eligible to vote for the respective candidates of the district."

#### AN ACT

RELATING TO REDISTRICTING OF THE PUBLIC EDUCATION COMMISSION; ESTABLISHING PUBLIC EDUCATION COMMISSION DISTRICTS; PROVIDING FOR STAGGERED TERMS AND THE FILLING OF VACANCIES; SETTING PRECINCTS; SETTING RESIDENCY REQUIREMENTS; REPEALING AND ENACTING SECTIONS OF THE NMSA 1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

## Chapter 3 Section 1 Laws 2021 (2nd S.S.)

SECTION 1. SHORT TITLE.--This act may be cited as the "2021 Educational Redistricting Act".

# Chapter 3 Section 2 Laws 2021 (2nd S.S.)

SECTION 2. COMMISSION MEMBERS.--The public education commission is composed of ten members to be elected from districts established by law.

#### Chapter 3 Section 3 Laws 2021 (2nd S.S.)

SECTION 3. ELECTION FOR STAGGERED TERMS.--

- A. Members of the public education commission shall be elected for staggered terms of four years.
- B. Members shall be elected at the general election for terms commencing on January 1 next succeeding their election.

- C. Members from districts two, three, five, six and seven shall be elected from the districts described in Sections 7, 8, 10, 11 and 12 of the 2021 Educational Redistricting Act at the 2022 and subsequent general elections.
- D. Members from districts one, four, eight, nine and ten shall be elected from the districts described in Sections 6, 9, 13, 14 and 15 of the 2021 Educational Redistricting Act at the 2024 and subsequent general elections.

#### Chapter 3 Section 4 Laws 2021 (2nd S.S.)

SECTION 4. RESIDENCE.--A candidate for the office of public education commissioner shall reside in the district for which the candidate files a declaration of candidacy at the time of such filing. A public education commissioner shall reside in the district from which the commissioner was elected or appointed and shall be deemed to have resigned if the commissioner changes residence to a place outside the district. Vacancies shall be filled as provided in Section 16 of the 2021 Educational Redistricting Act.

## Chapter 3 Section 5 Laws 2021 (2nd S.S.)

SECTION 5. PRECINCTS .--

- A. Precinct designations and boundaries used in the 2021 Educational Redistricting Act are those precinct designations and boundaries established pursuant to the Precinct Boundary Adjustment Act as revised and approved pursuant to that act by the secretary of state as of November 30, 2021.
- B. A board of county commissioners shall not create any precinct that lies in more than one public education commission district and shall not divide any precinct so that the divided parts of the precinct are situated in two or more public education commission districts. Votes cast in a public education commission election from precincts created or divided in violation of this subsection shall be invalid and shall not be counted or canvassed.

- A. A public education commissioner who is serving on the public education commission as of the effective date of this section shall serve the remainder of the term for which the commissioner was elected or appointed.
- B. The governor shall by appointment fill a vacancy on the public education commission. An appointment to fill a vacancy on the public education commission shall be for a term ending on December 31 after the next general election, at which election a person shall be elected to fill any remainder of the unexpired term.
- C. Before the general election of 2022, an appointment to fill a vacancy on the public education commission shall be made from the district as it existed when the person creating the vacancy in office was elected or appointed.
- D. After the general election of 2022, an appointment to fill a vacancy in district two, three, five, six or seven shall be made from the district as set out in Sections 7, 8, 10, 11 and 12 of the 2021 Educational Redistricting Act.
- E. After the general election of 2022 and before the general election of 2024, an appointment to fill a vacancy in district one, four, eight, nine or ten shall be made from the district as it existed when the person creating the vacancy in office was elected or appointed. After the general election of 2024, an appointment to fill a vacancy in district one, four, eight, nine or ten shall be made from the district as set out in Sections 6, 9, 13, 14 and 15 of the 2021 Educational Redistricting Act.

House Bill 2, aa, partial veto Approved December 21, 2021

#### AN ACT

MAKING GENERAL APPROPRIATIONS AND AUTHORIZING EXPENDITURES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

#### Chapter 4 Section 1 Laws 2021 (2nd S.S.)

SECTION 1. TRANSFER--APPROPRIATION CONTINGENCY FUND.--Of the federal funds received in the state treasury in the coronavirus state fiscal recovery fund pursuant to the federal American Rescue Plan Act of 2021, Sec. 9901, Public Law 117-2, 135 Stat. 223, one billion sixty-nine million one hundred seventy-five thousand dollars (\$1,069,175,000) is transferred to the appropriation contingency fund of the general fund to replace lost revenue due to the ongoing coronavirus disease 2019 public health emergency.

#### Chapter 4 Section 2 Laws 2021 (2nd S.S.)

SECTION 2. APPROPRIATIONS--APPROPRIATION CONTINGENCY FUND.--Of the one billion sixty-nine million one hundred seventy-five thousand dollars (\$1,069,175,000) transferred to the appropriation contingency fund of the general fund pursuant to Section 1 of this 2021 act, the following amounts are appropriated for expenditure in fiscal years 2022 through 2025, and any unexpended or unencumbered balance remaining at the end of fiscal year 2025 shall revert to the appropriation contingency fund:

- A. five hundred thousand dollars (\$500,000) to the administrative office of the courts for pretrial services monitoring;
- B. two million dollars (\$2,000,000) to the teacher loan repayment fund to carry out the provisions of the Teacher Loan Repayment Act;
- C. twenty million dollars (\$20,000,000) to the energy, minerals and natural resources department to plan, design, construct, improve, renovate, furnish and equip facilities and infrastructure at state parks statewide;
- D. three million five hundred thousand dollars (\$3,500,000) to the energy, minerals and natural resources department for orphan and inactive well planning, identification and program implementation;
- E. seven million dollars (\$7,000,000) to the economic development department for outdoor recreation grants;
- F. ten million dollars (\$10,000,000) to the department of environment to plan, design and construct projects to improve surface water quality and river habitats statewide;
- G. ten million dollars (\$10,000,000) to the department of finance and administration to provide housing assistance for homeless persons [contingent on a one hundred percent local match of expenditures for the same purpose]; LINE ITEM VETO

- H. fifteen million dollars (\$15,000,000) to the department of finance and administration for disbursement to the New Mexico mortgage finance authority for expenditure for energy-efficient affordable housing pursuant to the New Mexico Housing Trust Fund Act; provided that the funding shall not be used to match federal funds but may be used to match private or local funds;
- I. fifty million dollars (\$50,000,000) to the department of finance and administration to plan, design, construct, equip and furnish an acute care hospital in a county with a population of less than one hundred thousand, according to the most recent federal decennial census;
- J. four hundred thirty-five thousand dollars (\$435,000) to the department of finance and administration for personal services and employee benefits costs for the grants administration program;
- K. five hundred thousand dollars (\$500,000) to the department of finance and administration for temporary employees and contractors to assist the local government division of the department of finance and administration in advancing capital outlay projects and projects funded through the federal American Rescue Plan Act of 2021;
- L. fifteen million dollars (\$15,000,000) to the tourism department for tourism marketing advertising;
- M. five million dollars (\$5,000,000) to the human services department to assist food banks in meeting the needs of food-insecure New Mexicans;
- N. fifteen million dollars (\$15,000,000) to the employee group health benefits program of the general services department for public employee health care costs and testing related to coronavirus disease 2019;
- O. ten million dollars (\$10,000,000) to the department of transportation to plan, design, construct, renovate and equip electric vehicle charging stations statewide;
- P. ten million dollars (\$10,000,000) to the department of transportation to plan, design, construct, renovate and equip upgrades to regional airports statewide;
- Q. ten million dollars (\$10,000,000) to the department of transportation for the clean up New Mexico roadway beautification program; and
- R. one hundred forty-two million five hundred thousand dollars (\$142,500,000) to the department of transportation for acquisition of rights of way, planning, design and construction and to match other state funds for the following statewide infrastructure projects:
  - (1) the interstate 40 corridor in McKinley and Cibola counties;
  - (2) a new state road in Santa Teresa in Dona Ana county;

- (3) New Mexico highway 128 from Carlsbad to Jal in Eddy and Lea counties;
  - (4) New Mexico highway 180 in Grant county;
  - (5) Bobby Foster road to Mesa Del Sol in Bernalillo county;
- (6) interstate 25 from Montgomery boulevard to Comanche road in Bernalillo county;
  - (7) Cerrillos road in Santa Fe county;
  - (8) Pinon Hills boulevard in San Juan county; and
- (9) New Mexico highway 39 in Mosquero in Harding and San Miguel counties.

#### Chapter 4 Section 3 Laws 2021 (2nd S.S.)

SECTION 3. TRANSFERS--APPROPRIATION CONTINGENCY FUND--OTHER STATE FUNDS.--Of the one billion sixty-nine million one hundred seventy-five thousand dollars (\$1,069,175,000) transferred to the appropriation contingency fund of the general fund pursuant to Section 1 of this 2021 act, the following amounts are transferred from the appropriation contingency fund to the following other state funds:

- A. three million dollars (\$3,000,000) to the economic development department for the outdoor equity grant program fund; and
- B. fifteen million dollars (\$15,000,000) to the higher education program development enhancement fund for expanding enrollment in and graduation from nursing programs at state institutions of higher education.

#### Chapter 4 Section 4 Laws 2021 (2nd S.S.)

SECTION 4. APPROPRIATIONS--CAPITAL PROJECTS FUND.--Contingent on the transfer of one hundred thirty-three million sixty-six thousand eight hundred twelve dollars (\$133,066,812) authorized for the state in the capital projects fund pursuant to the federal American Rescue Plan Act of 2021, the following amounts are appropriated for expenditure in fiscal years 2022 through 2025:

A. one hundred twenty-three million sixty-six thousand eight hundred twelve dollars (\$123,066,812) to the department of information technology to plan, design, construct, renovate and equip broadband, including alternative and satellite broadband, statewide; and

B. ten million dollars (\$10,000,000) to the public education department to plan, design, construct, renovate and equip libraries and broadband infrastructure for Native American communities statewide.

#### Chapter 4 Section 5 Laws 2021 (2nd S.S.)

SECTION 5. APPROPRIATION--LEGISLATIVE PROCESSING SYSTEM.--Of the one billion sixty-nine million one hundred seventy-five thousand dollars (\$1,069,175,000) transferred to the appropriation contingency fund of the general fund pursuant to Section 1 of this 2021 act, one million dollars (\$1,000,000) is appropriated to the legislative council service for expenditure in fiscal year 2022 and subsequent fiscal years to initiate planning and design of a legislative processing system. Any unexpended or unencumbered balance remaining at the end of a fiscal year shall not revert to the appropriation contingency fund.

#### AN ACT

RELATING TO MEDICAL MALPRACTICE; MODIFYING DEFINITIONS IN THE MEDICAL MALPRACTICE ACT; RAISING PERSONAL LIABILITY AND RECOVERY CAPS; REPEALING LAWS 2021, CHAPTER 16, SECTIONS 1 AND 3; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

## Chapter 5 Section 1 Laws 2021 (2nd S.S.)

SECTION 1. Section 41-5-3 NMSA 1978 (being Laws 1976, Chapter 2, Section 3, as amended) is amended to read:

"41-5-3. DEFINITIONS.--As used in the Medical Malpractice Act:

- A. "advisory board" means the patient's compensation fund advisory board;
- B. "fund" means the patient's compensation fund;
- C. "health care provider" means a person, corporation, organization, facility or institution licensed or certified by this state to provide health care or professional

services as a doctor of medicine, hospital, outpatient health care facility, doctor of osteopathy, chiropractor, podiatrist, nurse anesthetist, physician's assistant, certified nurse practitioner, clinical nurse specialist or certified nurse-midwife or a business entity that is organized, incorporated or formed pursuant to the laws of New Mexico that provides health care services primarily through natural persons identified in this subsection:

- D. "hospital" means a facility licensed as a hospital in this state that offers inpatient services, nursing or overnight care on a twenty-four-hour basis for diagnosing, treating and providing medical, psychological or surgical care for three or more separate persons who have a physical or mental illness, disease, injury or rehabilitative condition or are pregnant and may offer emergency services. "Hospital" includes a hospital's parent corporation, subsidiary corporations or affiliates if incorporated or registered in New Mexico; employees and locum tenens providing services at the hospital; and agency nurses providing services at the hospital;
- E. "independent provider" means a doctor of medicine, doctor of osteopathy, chiropractor, podiatrist, nurse anesthetist, physician's assistant, certified nurse practitioner, clinical nurse specialist or certified nurse-midwife who is not an employee of a hospital or outpatient health care facility. "Independent provider" includes a business entity that is not a hospital or outpatient health care facility that employs or consists of members who are licensed or certified as doctors of medicine, doctors of osteopathy, chiropractors, podiatrists, nurse anesthetists, physician's assistants, certified nurse practitioners, clinical nurse specialists or certified nurse-midwives and the business entity's employees;
- F. "insurer" means an insurance company engaged in writing health care provider malpractice liability insurance in this state;
- G. "malpractice claim" includes any cause of action arising in this state against a health care provider for medical treatment, lack of medical treatment or other claimed departure from accepted standards of health care that proximately results in injury to the patient, whether the patient's claim or cause of action sounds in tort or contract, and includes but is not limited to actions based on battery or wrongful death; "malpractice claim" does not include a cause of action arising out of the driving, flying or nonmedical acts involved in the operation, use or maintenance of a vehicular or aircraft ambulance;
- H. "medical care and related benefits" means all reasonable medical, surgical, physical rehabilitation and custodial services and includes drugs, prosthetic devices and other similar materials reasonably necessary in the provision of such services;
- I. "occurrence" means all injuries to a patient caused by health care providers' successive acts or omissions that combined concurrently to create a malpractice claim;

- J. "outpatient health care facility" means an entity that is licensed pursuant to the Public Health Act as an outpatient facility, including ambulatory surgical centers, free-standing emergency rooms, urgent care clinics, acute care centers and intermediate care facilities and includes a facility's employees, locum tenens providers and agency nurses providing services at the facility. "Outpatient health care facility" does not include independent providers;
- K. "patient" means a natural person who received or should have received health care from a health care provider, under a contract, express or implied; and
  - L. "superintendent" means the superintendent of insurance."

#### Chapter 5 Section 2 Laws 2021 (2nd S.S.)

SECTION 2. Section 41-5-6 NMSA 1978 (being Laws 1992, Chapter 33, Section 4) is amended to read:

#### "41-5-6. LIMITATION OF RECOVERY.--

- A. Except for punitive damages and past and future medical care and related benefits, the aggregate dollar amount recoverable by all persons for or arising from any injury or death to a patient as a result of malpractice shall not exceed six hundred thousand dollars (\$600,000) per occurrence for malpractice claims brought against health care providers if the injury or death occurred prior to January 1, 2022. In jury cases, the jury shall not be given any instructions dealing with this limitation.
- B. Except for punitive damages and past and future medical care and related benefits, the aggregate dollar amount recoverable by all persons for or arising from any injury or death to a patient as a result of malpractice shall not exceed seven hundred fifty thousand dollars (\$750,000) per occurrence for malpractice claims against independent providers; provided that, beginning January 1, 2023, the per occurrence limit on recovery shall be adjusted annually by the consumer price index for all urban consumers.
- C. In calendar year 2022 and subsequent calendar years, the aggregate dollar amount recoverable by all persons for or arising from any injury or death to a patient as a result of malpractice, except for punitive damages and past and future medical care and related benefits, shall not exceed the following amounts for claims brought against an outpatient health care facility that is not majority-owned and -controlled by a hospital:
- (1) for an injury or death that occurred in calendar years 2022 and 2023, seven hundred fifty thousand dollars (\$750,000) per occurrence;
- (2) for an injury or death that occurred in calendar year 2024, five million dollars (\$5,000,000) per occurrence;

- (3) for an injury or death that occurred in calendar year 2025, five million five hundred thousand dollars (\$5,500,000) per occurrence;
- (4) for an injury or death that occurred in calendar year 2026, six million dollars (\$6,000,000) per occurrence; and
- (5) for an injury or death that occurred in calendar year 2027 and each calendar year thereafter, the amount provided in Paragraph (4) of this subsection, adjusted annually by the consumer price index for all urban consumers, per occurrence.
- D. In calendar year 2022 and subsequent calendar years, the aggregate dollar amount recoverable by all persons for or arising from any injury or death to a patient as a result of malpractice, except for punitive damages and past and future medical care and related benefits, shall not exceed the following amounts for claims brought against a hospital or an outpatient health care facility that is majority-owned and -controlled by a hospital:
- (1) for an injury or death that occurred in calendar year 2022, four million dollars (\$4,000,000) per occurrence;
- (2) for an injury or death that occurred in calendar year 2023, four million five hundred thousand dollars (\$4,500,000) per occurrence;
- (3) for an injury or death that occurred in calendar year 2024, five million dollars (\$5,000,000) per occurrence;
- (4) for an injury or death that occurred in calendar year 2025, five million five hundred thousand dollars (\$5,500,000) per occurrence;
- (5) for an injury or death that occurred in calendar year 2026, six million dollars (\$6,000,000) per occurrence; and
- (6) for an injury or death that occurred in calendar year 2027 and each calendar year thereafter, the amount provided in Paragraph (5) of this subsection, adjusted annually by the consumer price index for all urban consumers, per occurrence.
- E. The aggregate dollar amounts provided in Subsections B through D of this section include payment to any person for any number of loss of consortium claims or other claims per occurrence that arise solely because of the injuries or death of the patient.
- F. In jury cases, the jury shall not be given any instructions dealing with the limitations provided in this section.
- G. The value of accrued medical care and related benefits shall not be subject to any limitation.

- H. A health care provider's personal liability is limited to two hundred fifty thousand dollars (\$250,000) for monetary damages and medical care and related benefits as provided in Section 41-5-7 NMSA 1978. Any amount due from a judgment or settlement in excess of two hundred fifty thousand dollars (\$250,000) shall be paid from the fund, except as provided in Subsection I of this section.
- I. Until January 1, 2027, amounts due from a judgment or settlement against a hospital or outpatient health care facility in excess of seven hundred fifty thousand dollars (\$750,000), excluding past and future medical expenses, shall be paid by the hospital or outpatient health care facility and not by the fund. Beginning January 1, 2027, amounts due from a judgment or settlement against a hospital or outpatient health care facility shall not be paid from the fund.
- J. The term "occurrence" shall not be construed in such a way as to limit recovery to only one maximum statutory payment if separate acts or omissions cause additional or enhanced injury or harm as a result of the separate acts or omissions. A patient who suffers two or more distinct injuries as a result of two or more different acts or omissions that occur at different times by one or more health care providers is entitled to up to the maximum statutory recovery for each injury."

#### Chapter 5 Section 3 Laws 2021 (2nd S.S.)

SECTION 3. REPEAL.--Laws 2021, Chapter 16, Sections 1 and 3 are repealed.

#### Chapter 5 Section 4 Laws 2021 (2nd S.S.)

SECTION 4. EFFECTIVE DATE.--The effective date of the provisions of this act is January 1, 2022.

SECTION 5. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.

RELATING TO THE REDISTRICTING OF THE HOUSE OF REPRESENTATIVES; ESTABLISHING REPRESENTATIVE DISTRICTS; PROVIDING THE METHOD FOR ELECTING REPRESENTATIVES; PROVIDING FOR THE FILLING OF VACANCIES; SETTING PRECINCTS; FIXING THE NUMBER, RESIDENCE AND TERMS OF REPRESENTATIVES; REPEALING AND ENACTING SECTIONS OF THE NMSA 1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

#### Chapter 6 Section 1 Laws 2021 (2nd S.S.)

SECTION 1. SHORT TITLE.--This act may be cited as the "2021 House Redistricting Act".

## Chapter 6 Section 2 Laws 2021 (2nd S.S.)

SECTION 2. MEMBERSHIP.--The house of representatives is composed of seventy members to be elected from districts that are contiguous and that are as compact as is practicable.

#### Chapter 6 Section 3 Laws 2021 (2nd S.S.)

SECTION 3. RESIDENCE.--At the time of filing a declaration of candidacy for the office of representative, a candidate shall reside in the district for which the candidate files. Thereafter, if a representative permanently removes the representative's residence from or maintains no residence in the district from which the representative was elected, the representative shall be deemed to have resigned, and a successor shall be selected as provided in Section 4 of the 2021 House Redistricting Act.

## Chapter 6 Section 4 Laws 2021 (2nd S.S.)

SECTION 4. ELECTIONS--VACANCIES.--

- A. Members of the house of representatives shall be elected for terms of two years.
- B. If a vacancy occurs in the office of representative for any reason, the vacancy shall be filled as follows:
- (1) for a representative district that is situated wholly within the exterior boundaries of a single county, the board of county commissioners of that county shall appoint the representative to fill the vacancy; and
  - (2) for a representative district situated within two or more counties:
- (a) the board of county commissioners of each county in the representative district shall submit one name to the governor; and

- (b) the governor shall appoint the representative to fill the vacancy from the list of names so submitted.
- C. An appointment to fill a vacancy in the house of representatives shall be for a term ending on December 31 after the next general election.
- D. An appointment to fill a vacancy made before the general election of 2022 shall be made from the district as it was described in Section 2-7E-1 NMSA 1978, as established by the court in *Egolf v. Duran*, D-101-CV-2011-02942 (1st Dist. Ct., Judgment and Final Order on Remand (State House of Representatives Trial) filed February 28, 2012). On or after the general election of 2022, a vacancy shall be filled by appointment from the district as set out in the 2021 House Redistricting Act.

#### Chapter 6 Section 5 Laws 2021 (2nd S.S.)

SECTION 5. PRECINCTS .--

- A. Precinct designations and boundaries used in the 2021 House Redistricting Act are those precinct designations and boundaries established pursuant to the Precinct Boundary Adjustment Act and revised and approved pursuant to that act by the secretary of state as of November 30, 2021.
- B. A board of county commissioners shall not create any precinct that lies in more than one representative district and shall not divide any precinct so that the divided parts of the precinct are situated in two or more representative districts. Votes cast in any general, primary or other statewide election from precincts created or divided in violation of this subsection are invalid and shall not be counted or canvassed.

#### AN ACT

RELATING TO THE REDISTRICTING OF THE SENATE; ESTABLISHING SENATORIAL DISTRICTS; PROVIDING THE METHOD FOR ELECTING SENATORS; PROVIDING FOR THE FILLING OF VACANCIES; SETTING PRECINCTS; FIXING

THE NUMBER, RESIDENCE AND TERMS OF SENATORS; REPEALING AND ENACTING SECTIONS OF THE NMSA 1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

#### Chapter 7 Section 1 Laws 2021 (2nd S.S.)

SECTION 1. SHORT TITLE.--This act may be cited as the "2021 Senate Redistricting Act".

#### Chapter 7 Section 2 Laws 2021 (2nd S.S.)

SECTION 2. MEMBERSHIP.--The senate is composed of forty-two members to be elected from districts that are contiguous and that are as compact as is practicable.

#### Chapter 7 Section 3 Laws 2021 (2nd S.S.)

SECTION 3. RESIDENCE.--At the time of filing a declaration of candidacy for the office of senator, the candidate shall reside in the district for which the candidate files. Thereafter, if a senator permanently removes the senator's residence from or maintains no residence in the district from which the senator was elected, the senator shall be deemed to have resigned, and the senator's successor shall be selected as provided in Section 4 of the 2021 Senate Redistricting Act.

## Chapter 7 Section 4 Laws 2021 (2nd S.S.)

SECTION 4. ELECTIONS--VACANCIES.--

- A. Members of the senate shall be elected for terms of four years.
- B. If a vacancy occurs in the office of senator for any reason, the vacancy shall be filled as follows:
- (1) for a senate district that is situated wholly within the exterior boundaries of a single county, the board of county commissioners of that county shall appoint the senator to fill the vacancy; and
  - (2) for a senate district situated within two or more counties:
- (a) the board of county commissioners of each county in the senate district shall submit one name to the governor; and
- (b) the governor shall appoint the senator to fill the vacancy from the list of names so submitted.

- C. All appointments to fill vacancies in the senate shall be for a term ending on December 31 subsequent to the next succeeding general election, at which general election a person shall be elected to fill the remainder of any unexpired term.
- D. An appointment to fill a vacancy made before the general election of 2024 shall be made from the district as it was described in Section 2-8E-1 NMSA 1978, as established by the court in *Egolf v. Duran*, D-101-CV-2011-02942 (1st Dist. Ct., Judgement and Final Order (State Senate Trial) filed January 25, 2012). On or after the general election of 2024, a vacancy shall be filled by appointment from the district as set out in the 2021 Senate Redistricting Act.

#### Chapter 7 Section 5 Laws 2021 (2nd S.S.)

SECTION 5. PRECINCTS .--

- A. Precinct designations and boundaries used in the 2021 Senate Redistricting Act are those precinct designations and boundaries established pursuant to the Precinct Boundary Adjustment Act and revised and approved pursuant to that act by the secretary of state as of November 30, 2021.
- B. A board of county commissioners shall not create any precinct that lies in more than one senate district and shall not divide any precinct so that the divided parts of the precinct are situated in two or more senate districts. Votes cast in any general, primary or other statewide election from precincts created or divided in violation of this subsection are invalid and shall not be counted or canvassed.
